

Schools of Dance

2025-2026 Registration

HSL Youth Foundation Inc. Schools of Dance are now registering students for several schools located in South and Central Texas.

The 2025-2026 benefit is available to members and non-members who will be 3 to 17 years of age as of Sept. 1, 2025. Students may enroll in any school of dance they choose.

Our schools of dance are designed to teach the art of dance in a wholesome atmosphere of fun, work, physical exercise and fellowship. Each school of dance teaches varying degrees of tap, ballet and jazz. A recital is held at the end of the season.

Dance class tuition is \$38 per month for nine months or you may choose to pay the full amount of \$342 at registration.

A \$200 registration fee is due at the time of enrollment.

Active Hermann Sons Life members receive a waiver for the registration fee. Tuition fees are charged to accounts provided the first of every month, unless that falls on a weekend and then it would be charged the following Monday. Tuition and registration fees pay expenses during the year and the Home Office cost for teacher salaries and any other expenses that are incurred.

Each teacher is an employee of HSL Youth Foundation Inc.
The teacher(s) and at least two parent volunteers are responsible for the day-to-day operation of the school.

There will be several opportunities for parents to volunteer throughout the year. We encourage you to ask the teacher or parent liaison about these opportunities. (Examples include the Fund-raising Committee, Recital Committee and classroom monitors.)

All parent volunteers are required to pass a yearly background check. The background check form is available through your school of dance teacher.



Registration Instructions



Please Note: If you have already set up an account with Class Juggler for Dance registration you do not need to set up a new account for the 2025-2026 season.

Steps to set up a new account:

- 1. Go to hermannsonslife.org and scroll down to the bottom of the Home Page and find the "Registration" link.
- 2. Click on the "Register Now" button
- 3. Set up your username (your email address) and password.
- 4. Add all of your family, student and payment information.
- 5. Once all your information is entered you will then go to the "Shopping Options" and choose "Shop for Classes."
- 6. Once you have opened the School of Dance Store you will see a list of location options to choose from.
- 7. Choose the location and add your students then add these classes to your cart.
 - 8. Check out of cart without adding anything else to your order.
 - 9. You will receive an email that you have checked out.

Our team will then review and process all orders within 1-2 business days.

You will receive a confirmation email and the first month's tuition payment will be withdrawn from the account on file or the full payment if you chose that option. If you are a non-member an additional \$200 will be withdrawn as a non-membership registration fee. To pay by check, please contact Tammi Sutherland at

Cancellation Policy



Dance tuition will be charged the first of every month. To drop your student and not be charged tuition, the Member Benefits Department must receive a drop notification in writing from the parent or guardian listed on the account no later than two weeks prior to the tuition being charged. If you choose to pay in full at the beginning of the season, we will have to receive written notice of your child dropping. A check with the remainder of your child's tuition will be mailed to the address we have on file within two weeks of receiving notification.
